
Subject: Aarupadai Veedu Medcial College, Pondicherry- Renewal of permission for admission to

Sir,
In continuation of this Department's letters of even number dated 15.7.04 on the subject mentioned above, I am directed to say that the Supreme Court of India in its directions dated 1.8.05 in W.P.(c) No. 300 of 2005 in the matter of Global Educational Net v/s UOI and Anr., directed the Medical Council of India(MCI) to conduct verification of compliance and send its report and recommendations for renewal of permission to the Central Govt. by 13.8.05. The Central Govt. was directed to pass order by 17.8.05. Accordingly, Medical Council of India after conducting compliance verification inspection and noting the facilities available, have recommended for grant of renewal of permission for admission of 6th batch of 100 (one hundred only) MBBS students in your college for the academic year 2005-06. The Central Government after taking into consideration the recommendations of the MCI, have decided to grant renewal of permission for admission of 6th batch of 100 students at Aarupadai Veedu Medcial College, Pondicherry for the academic year 2005-06. The permission is, however, subject to the condition that admission process for the academic year 2005-06 is completed as per prescribed time schedule. A copy of inspection report of MCI is enclosed herewith

Further the college is in its 6th year of inception and has become due for recognition of the MBBS course under Section 11(2) of IMC Act 1956. You are, therefore requested to take necessary action for recognition of the college during the academic session 2005-06 itself. Please note that no further renewal of permission will be granted if the college failed to get itself recognized under Section 11(2) of IMC Act during the academic year 2005-06.


